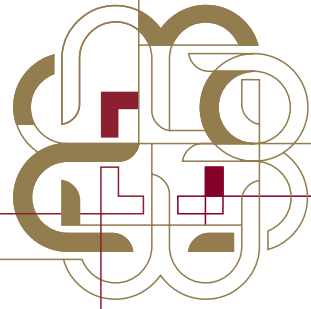

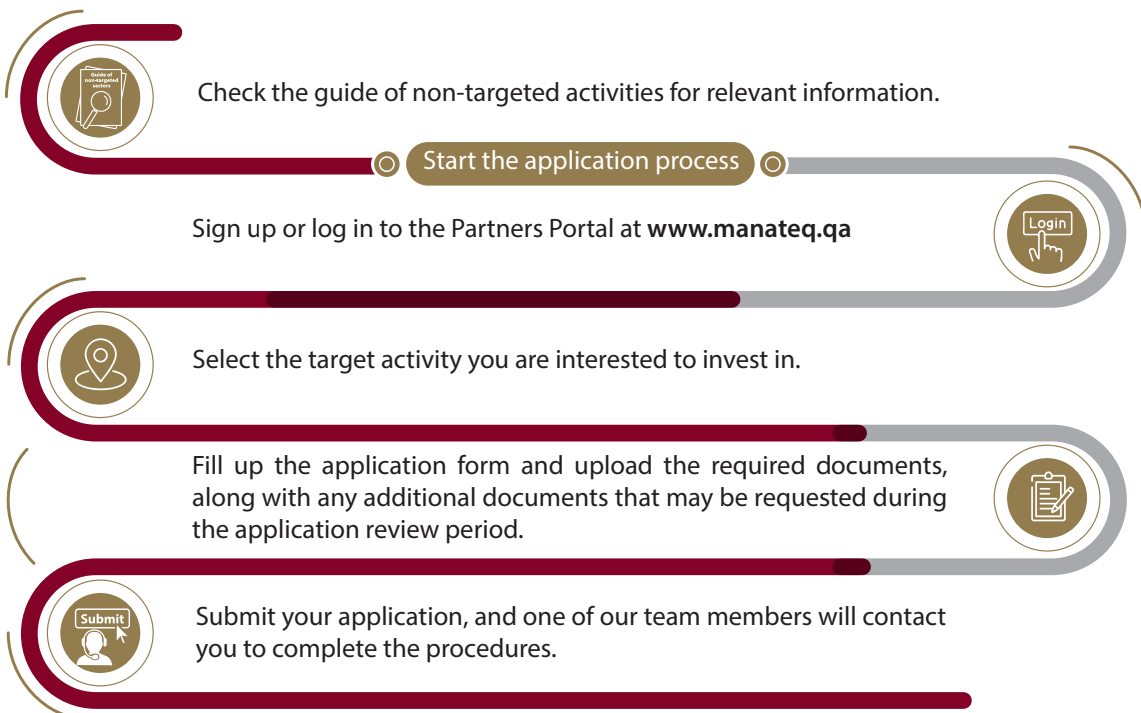
Objective:

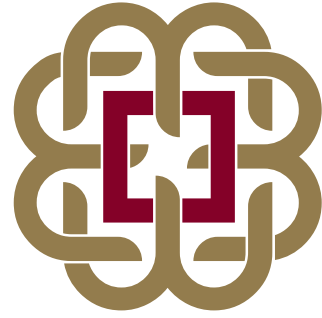
